FROM THE DESK OF THE PRESIDENT

Fellow Sisters and Brothers: On FSS - As I'm sure most of you have heard, Management is going to discontinue the Flat Sequencing System (FSS) within the next few months in Post Offices around our local area. The Union has not been officially notified from the Postal Service but there has been much talk among Management about this matter. I've spoken with several Postmasters and Managers, and they have all stated that FSS will be discontinued by the summertime, at the latest. The Post Offices within our Branch receive FSS from the Van Nuys Post Office and Management plans to discontinue this in several phases. From what Management has stated, the phases will be implemented as early as April through July of 2023. They plan to phase out starting from the farthest Post Offices they serve from the Van Nuys Post Office and working their way closer until complete. As the flat mail volume has declined over the years, the FSS has not been cost effective for Management to continue operating. The Postal Service has been taking drastic measures to eliminate unnecessary cost and increase revenue. They released a statement for the 10-year Delivering for America (DFA) which states: Our Delivering for America (DFA) plan was published on March 23, 2021, to transform the United States Postal Service from an organization in financial and operational crisis to one that is self-sustaining and high performing. In the year since, the Postal Service has aggressively advanced core DFA strategies and initiatives. While much work remains to be done in order to address the Postal Service's financial and operational performance, the 10year DFA transformation plan has already demonstrated that the path forward is achievable and that the organization can be financially self-sustaining, high performing, and provide excellent service to the nation. This report describes progress toward goals of the plan and reviews activities undertaken to date.

There has also been talk amongst Management that once the FSS machines are discontinued and disassembled, other Installations and/or post offices within the Van Nuys Installation might be moved into the Van Nuys Post Office in place of the FSS machines. This is also a part of the DFA as the Postal Service is attempting to minimize cost for paying multiple contract drivers to move the mail to multiple post offices rather than combining multiple post offices under one roof. Once the Union is officially notified by Management for discontinuing FSS, with the phases and dates, an updated article will be provided in the Mail Call.


Discipline/Attendance - On another note, Discipline for Unsatisfactory Attendance has been the flavor of the month for Management. We have had many carriers issued discipline due to unscheduled sick calls over the past month. Management is taking firm action by issuing discipline to address the problem of unscheduled sick calls. The biggest issue Management has with the unscheduled absences is the excess use of overtime and overtime grievances. Carriers might not realize this, but if a carrier calls out sick, Management usually must split that carrier's route. In most cases, Management violates the overtime provisions to do so and/or work carriers in excess of their daily and weekly work hours to get the mail delivered. Either of these situations leads to grievances as a result of the sick call. Monetary grievance settlements are also being closely monitored by upper-level management in order to minimize financial costs for the Postal Service. Carriers should avoid unscheduled absences as much as possible as attendance related issues are the simplest way for a carrier to lose their job from the Postal Service. Unscheduled sick calls also put a burden on your fellow coworkers to work longer hours than preferred. Furthermore, as carriers fall under the Federal Employee guidelines, it is ideal for a carrier to have a healthy sick leave balance as we are not covered under state disability for long term medically related absences. In such cases, carriers have to use their own sick leave, annual leave or leave without pay during a long-term absence.

And....From the Desk of Vice-President

On 01/29/2023, I had the opportunity to attend an Office of Workers Compensation Programs training taught by Regional Workers Compensation Assistants Tami Seastrand and Kathy Akana from Region 1 of the NALC. This was a three-day training that consisted of basic and advanced OWCP training which relates to the issue of when a letter carrier gets injured on the job due to either traumatic injury or an occupational disease. Overall, I am confident to report that I came back with far more knowledge than I had before. There were many takeaways and plenty of information to pass on to my fellow letter carriers. I will try and keep it as simple as possible in this article in hopes that it will help an injured employee be able to maneuver the unknown at the onset of an on-the-job-injury. If you are injured on the job, one of the first things you should do is contact your supervisor and request medical treatment should you need it. Under FECA, you have many rights when you become injured on the job:

- YOU HAVE THE RIGHT to file a claim for workers compensation without fear of retaliation under the Whistleblower's Protection Act and enforced by the Department of Labor.
- YOU HAVE THE RIGHT to select your own Doctor and can refuse treatment by the assigned Postal Doctor (contracted doctors by USPS are not for the best interest of your health).
- YOU HAVE THE RIGHT to elect Continuation of Pay (COP) paid leave while disabled due to your on-thejob-injury (you can select COP for up to 45 calendar days when you file your claim on ECOMP.DOL.GOV & on a PS 3971).
- YOU HAVE THE RIGHT to return to work with medical restrictions and if USPS has available modified work within those restrictions.
- YOU HAVE THE RIGHT to have all your medical bills, treatments, medicine and paid travel to medical appointments related to your injury paid under FECA.
- YOU HAVE THE RIGHT to obtain a CA-16, Authorization for Examination and/or Treatment (within the first 7 days from the date of your injury) from your supervisor.

ONLY THE CA-17, DUTY STATUS REPORT, should be given to your supervisor. All other forms should be uploaded directly to your claim on ECOMP.DOL.GOV. I also advise you to contact your shop steward or the Branch in the event that you do become injured to ensure that your claim is approved with little to no delays. Finally, I'd like to thank Greater East Bay Branch 1111 for hosting us and treating us well while we were in Richmond, California for the OWCP training.
