## FROM THE DESK OF THE PRESIDENT

**Fellow brothers and sisters** – As we conclude Year 2021, I would like to thank all Letter Carriers for their hard work and dedication during the peak season. In addition, I wish all members and their families **Happy Holidays** and a **Happy New Year**.

**COVID-19 Updates (again!)** – As we start the new year, much to our dismay, the COVID-19 pandemic is still very much with us. As a result, several COVID-19 related Memorandums have been extended through February 11, 2022. These memoranda include:

- temporary expanded sick leave for dependent care ([M-01910](#))
- temporary use of the 7:01 rule ([M-01913](#))
- temporary workplace changes to promote social distancing ([M-01915](#))
- temporary use of TCAs ([M-01916](#))
- reinstatement of temporary additional paid leave for CCAs ([M-01965](#)).

An agreement was reached giving local parties the ability to mutually develop a sign-up process for full-time employees who previously did not, or could not, place their names on either the overtime desired list or work assignment list ([M-01971](#)). Also extended through February 11, 2022, is a USPS memorandum ([M-01914](#)) which instructs managers and supervisors to allow liberal changes of schedule to accommodate employees who are dealing with childcare issues related to the pandemic.

COVID-19 related cases have also increased within our Branch as the holiday season is coming to an end. As a reminder, carriers can file a Traumatic Injury case (Form CA-1) with the Department of Labor, Office of Workers Compensation if they have contracted COVID-19 at work.

If the claim is approved by Department of Labor, carriers will be eligible for Continuation of Pay (COP) for the period of the quarantine and any medical expenses as a result of COVID. Carriers may file a CA-1 claim at [www.ecomp.dol.gov](http://www.ecomp.dol.gov). Since COVID-19 has not ended, remember to wear your masks while at work, especially if social distancing is not possible. Please stay safe brothers and sisters.

First and foremost, I would like to say thank you for electing me as Vice-President of Branch 2200. I look forward to working with President Karchikyan and to serving our members! The NALC Mutual Benefit Association (MBA) has introduced an **Individual Disability Income** policy for active members 18 to 59 years old who want to cover themselves financially in the event of such illness or injury. MBA states “Disability Income insurance helps cover you when the unexpected happens. # JOHN S. MIKITA

# SCHOLARSHIP

The John S. Mikita Scholarship Fund, sponsored by Branch 2200 of the National Association of Letter Carriers, each year awards one \$1,500.00 scholarship to a child or grandchild of a member in good standing. Applicants must be high school seniors and must meet all of the following eligibility criteria in order to be considered for awards in the 2022-2023 competition.

## ELIGIBILITY CRITERIA

Applicant must be son, daughter, grandchild or legally adopted stepchild of an active, retired, or deceased letter carrier of NALC Branch 2200.

**Applicant's parent/grandparent must be a member in good standing of NALC at least one year prior to making application or one year prior to death.** Applicant must be a high school senior when making application and must submit the form provided on the reverse side, signed by the NALC member. This form must be returned to Branch 2200 by April 1, 2022.

## REGULATIONS

Scholarship is to be used toward pursuing an undergraduate degree at an accredited four-year college of the recipient's choice. Winners may accept other college scholarship assistance in addition to the Branch award.

Any change of schools must be done only with permission of the Branch Scholarship Committee. If winner suffers certified serious illness, scholarship will be held in abeyance for not more than one year.

**If applicant decides to attend a two-year college first, the scholarship money will be held in abeyance for up to two years until entry in a four-year college.**

If unusual conditions are going to require an interruption in schooling, recipient must state reason(s) in writing to the Scholarship Committee and request that scholarship be held in abeyance. Request(s) will be reviewed by the Committee and a decision rendered. If the Branch member is suspended from the Branch, discontinues union membership, or enters supervision, scholarship will be canceled.

## TERMS OF AWARD

The members of the Scholarship Committee will judge applicants each year. Winners are judged on the basis of secondary school records (50%), personal qualifications based on biography outline and essay responses (50%). If no suitable applicant applies, the award will be carried over to the following year, with an additional second award in the amount of \$500.

**Decisions of the judges are final.** Only the winner will be notified no later than June 1, 2022.

Award money is to be used for required college fees and course materials. **Scholarship payment will be made directly to the school, upon notification by the winner of enrollment in an accredited four-year college.**

**ELECTION 2021**

By now the results of our most recent election are in the books. As Election Committee Chair, I wish to congratulate Calvin Rich on being elected Vice-President of Branch 2200. We should also recognize and thank outgoing Vice-President Carolyn Zorn for her contribution to our Branch during the last three years. The COVID-19 pandemic made things difficult to manage and Carolyn aided in smoothing our operations.

However, not all of the news coming out of the election is positive. I had the enviable task of Chairperson of the Election Committee. The Committee consisted of five members of the Branch from various cities/stations. Our time was spent preparing the election ballots for mailing, preparing and mailing the candidates' campaign letters and, of course, tallying the ballots to determine the outcome. We prepped 807 ballots/pieces for each of these mailings. Out of the 807 ballots that were mailed out, we received back only 264, which constitutes only one-third of the total ballots mailed. This means that two out of every three members did not exercise their right and their responsibility to vote. Two-thirds made a conscious decision to ignore casting a ballot. In future elections (and there will be others), I hope that all of you will vote....and if unsure of "who to vote for," please ask one of your fellow carriers if they have any knowledge of the candidates.

**I sincerely thank all of you who did vote.** The goal of our Union is member involvement. We do our best to achieve this through education and meetings. The level of involvement and participation is up to each individual member. Voting in a Branch Election is a very important aspect of being a Union member. With election participation at such a low percentage, it means that only fifteen percent (15%) of the membership determined who would be our next Vice-President. Think about that – are we representing you? It is a very important duty for each member to vote. I hope that one of my fellow members can tell me why there was such a low turnout and what steps might be taken to change this.

Again, let's welcome Calvin Rich as our new Vice-President and Amy Lee as our new Financial Secretary. Let's welcome myself, Keith Lineman, as our new Health Benefits Representative and Jan Seichert as a new Branch trustee. Let's give a shout out to Walter Washington who has served our Branch for many, many, many years. And, once again, thank you to all of you who took the time out of your busy schedule to cast a ballot. The Branch genuinely appreciates your participation.
