FROM THE DESK OF THE PRESIDENT

Fellow brothers and sisters....


COVID 19 – Although the majority of the COVID-19 related issues have subsided, the National Parties have extended several memorandums until May 6, 2022. These include: Temporary expanded sick leave for dependent care (M-01910); Temporary use of the 7:01 rule (M-01913); Temporary workplace changes to promote social distancing (M-01915); Temporary use of TCAs (M-01916); Reinstatement of temporary additional paid leave for CCAs (M-01965); and the agreement allowing local parties the ability to mutually develop a sign-up process for full-time employees who previously did not, or could not, place their names on either the overtime desired list or on the work assignment list (M-01978).

Annual Leave Carryover – The NALC and the Postal Service have agreed to a Memorandum of Understanding (<u>M-01979</u>) that increases the maximum allowable annual leave carryover amounts outlined in the Employee and Labor Relations Manual (ELM). For leave year 2023, regular work force career employees covered by the USPS-NALC National Agreement may carryover 520 hours of accumulated annual leave from Leave Year 2022 to Leave Year 2023. This will also provide a cushion for the extra pay period (PP27-2022)of annual leave that carriers will earn this year.

H.R. 3076 Postal Service Reform Act – President Biden signed the Postal Service Reform Act into law on April 6^{th.} This was largely due to all of the hard-working letter carriers and the NALC congressional liaisons across the nation who took the time to contact their representatives and inform them of the importance of the Postal Service Reform Act. I would also like to thank Carolyn Zorn and Leroy Collier from our Branch for their hard work and taking the time to attend the Lobby trip in DC, participating in the passage of the Postal Service Reform Act.

"With this bill, we're repealing the pre-funding mandate and setting the Postal Service on a more sustainable and stable financial footing," President Biden said. "We're guaranteeing that the mail will continue to be delivered six days a week. And the bill increases transparency by requiring the Postal Service to develop an online public dashboard updated weekly with local and national service performance data. Today, we enshrine in law our recognition that the Postal Service is fundamental to our economy, to our democracy, to our health, and the very sense of who we are as a nation." After 12 years of fighting for meaningful postal reform, NALC is delighted to see President Biden sign this bill into law.

CARRIERS SAFE AND SOUND – By Ric Roldan

We all need reminders: Practice good safety habits while on the job performing your assignment. Work safely and as though you are being watched by someone, sometime, somewhere on your route. It's not just by management that you are being observed, but also by the general public, so always work safe. You must be on guard, and at your best, while in uniform, working safely throughout the day. Whatever you do, good or bad, the general public associates it to the entire work force, so remember to always be professional and work safely.

I once witnessed a carrier in my neighborhood running back to his LLV while being chased by a dog. Unfortunately, his satchel and dog spray were left in the vehicle. He was able to jump slide to safety because he had left the door open to his LLV. But imagine what might have happened if he had left the engine running, didn't set the brake, and accidentally hit the gear into "Reverse" or "Drive" while he was jumping in to get away from that dog. There's the dog....BARKING and chasing, as he tumbles out of the vehicle and it runs into a tree, another parked car, or worse yet, a child.

Follow safety protocols. When dismounting your vehicle, make sure the LLV is in park, set the hand brake, and turn off the engine. You carriers who have not followed safety protocol can share your experience of rollaway accidents or having to chase after the LLV before it hits something or someone. How about the carrier who forgets to buckle the seatbelt or neglects to close the door while driving? Even better (or worse), going through intersections where every driver on the road can see your safety practices not being employed and being T-boned by another car with no protection on the carrier's side? Pray that, if struck and ejected from the LLV, you are not seriously injured. Otherwise, there might be one less for dinner at home. Do your fellow workers proud and keep your family intact by practicing safely habits as letter carriers. Remember to take the time to do your job as a letter carrier safely. This IS what we are paid to do.

COMING UP ON SUMMER –Know the signs of heat stress. You should understand what heat stress is, and how it can affect your health and safety. Here are some things to look out for:

- Hot, dry skin or profuse sweating
- Headache
- Confusion or dizziness
- Nausea
- Muscle cramps
- Weakness or fatigue
- Rash

Finally, it's important to notify your supervisor or call 911 if you're experiencing signs of heat-related illnesses. "Letter carriers need to remember to respond appropriately to the weather and immediately notify their supervisor if you feel that you are experiencing heat-stress symptoms or other weather-related issues," NALC President Fredric Rolando said. **"Bottom line: Do not put yourself in danger," Rolando said – Posted by our National Office**
