#### From The Desk of the President

**Brothers and Sisters.....Happy Holidays!!** I would like to take this opportunity and wish all of you Happy Holidays and a Happy New Year as we say farewell to 2023. I would also like to thank all of you hard-working letter carriers for putting in the long hours through this peak holiday season. I hope all of you were able to spend time with your friends, family and loved ones for the Holidays and, as a friendly reminder, please be safe and responsible.

Mail Theft/Personal Theft – Mail theft continues to be a problem throughout the nation. There have been numerous reports of LLV's being broken into, in which mail and packages are being stolen. In some cases, the LLV's have actually been stolen. Carriers are not to leave mail or packages in front of the LLV's when delivering park and loop swings, or when the LLV is out of site for a period of time. These thieves have gone as far as stealing carriers' personal items from the LLV as well. In one case, a carrier's car keys were stolen along with his wallet. It is a good idea to leave personal items that are not needed, in your locker at the Post Office, such as car keys. All a carrier really needs on the route is their driver's license and money for lunch, everything else could potentially be an item that may be taken. In case a carrier is a victim of theft, a carrier can file a claim for reimbursement under Article 27 of the Joint Contract Administration Manual (JCAM) within 14 days of when the incident occurs. If you are a victim of theft, notify the Postal Service along with the Union.

### NALC BRANCH 2200 AUDIT REPORT August 22, 2023

On August 22,, 2023 The Trustees, Robert Burskey, Jan Siechert, and Chairman Leroy Collier, with the assistance of the Secretary-Treasurer Nancy Norman and financial secretary Amy Lee conducted an audit of the records of NALC Branch 2200. We reviewed records from December 1, 2022 to June 30, 2023.

We reviewed statements of the United Business Bank and Glendale Area Schools Credit Union, Including checking, savings, and money market accounts.

The Audit Committee selected random banking and Costco visa charges and matched them to the corresponding receipts for accuracy.

We noted that membership dues deposits are made by direct deposit from our national office to our United business bank checking account and a printout of the dues deposits was copied from the National offices website. These deposits were reviewed and found to be in order.

Direct dues are collected from certain members and recorded on the monthly financial log. The dues of the full time president are withheld from his biweekly salary and also recorded on the monthly financial log. We found these records to be in order.

We reviewed cash deposits and found them to be in order. We reviewed the deposit receipts with the bank statements and found them to be in order. We also compared the checks issued with the bank statements and found both to be in good order. We reviewed the monthly treasurer's report and the account balances and found them to be in order.

We reviewed the Costco account and the Costco visa card statements with the accompanying receipts, they were found to be in order.

The Costco account and the Costco Visa card received rebates, the Costco Visa card rebates are paid by direct deposit to the UBB checking account each year based on amount charged to account. The rebate amounts were donated to the MDA account to be used for fundraisers and donations to the Muscular Dystrophy Association. We found that account to be in order.

# <u>JOHN S. MIKITA</u> <u>SCHOLARSHIP</u>

The John S. Mikita Scholarship Fund, sponsored by Branch 2200 of the National Association of Letter Carriers, each year awards one \$1,500.00 scholarship to a child or grandchild of a member in good standing. Applicants must be high school seniors and must meet all of the following eligibility criteria in order to be considered for awards in the 2024-2025 competition.

### **ELIGIBILITY CRITERIA**

Applicant must be son, daughter, grandchild or legally adopted stepchild of an active, retired, or deceased letter carrier of NALC Branch 2200. <u>Applicant's parent/grandparent must be a</u> <u>member in good standing of NALC at least one</u> <u>year prior to making application or one year</u> <u>prior to death</u>. Applicant must be a high school senior when making application and must submit the form provided on the reverse side, signed by the NALC member. This form must be returned to Branch 2200 by April 1, 2024.

#### **REGULATIONS**

Scholarship is to be used toward pursuing an undergraduate degree at an accredited fouryear college of the recipient's choice. Winners may accept other college scholarship assistance in addition to the Branch award.

Any change of schools must be done only with permission of the Branch Scholarship Committee. If winner suffers certified serious illness, scholarship will be held in abeyance for not more than one year. If applicant decides to attend a two-year college first, the scholarship money will be held in abeyance for up to two years until entry in a four-year college.

If unusual conditions are going to require an interruption in schooling, recipient must state reason(s) in writing to the Scholarship Committee and request that scholarship be held in abeyance. Request(s) will be reviewed by the Committee and a decision rendered. If the Branch member is suspended from the Branch, discontinues union membership, or enters supervision, scholarship will be canceled.

#### TERMS OF AWARD

The members of the Scholarship Committee will judge applicants each year. Winners are judged on the basis of secondary school records (50%), personal qualifications based on biography outline and essay responses (50%). If no suitable applicant applies, the award will be carried over to the following year, with an additional second award in the amount of \$500.

**Decisions of the judges are final**. Only the winner will be notified no later than June 1, 2024.

Award money is to be used for required college fees and course materials. <u>Scholarship payment</u> will be made directly to the school, upon notification by the winner of enrollment in an accredited four-year college.

#### **2023 HEALTH BENEFITS SEMINAR**

As Branch 2200's Health Benefits Representative, I recently had the privilege of attending the latest NALC Health Benefits Seminar. The seminar was held from October 15 through October 18<sup>th</sup>. Branch President Serop Karchikyan also attended the seminar. Held for the first time in person since 2019, in Las Vegas, hundreds of representatives and/or designees, gathered to learn about the latest updates and changes to our Union health plan for 2024 and beyond. During this 3-day event, attendees were given a wealth of information from the various training classes. In this article, I will highlight the subjects which affect many of our health plan members.

First and foremost, it is of the utmost importance that we increase enrollment in our plan. The more carriers enrolled in the plan brings a positive impact regarding premiums. It is a shared responsibility. If you are enrolled in our health plan, spread the word around the workroom floor to your fellow carriers who aren't enrolled. Inform them of the great advantages our plan provides, not only lower premiums but better coverage. Be a positive voice for your plan. The seminar classes provided valuable insight into our plan. One class demonstrated how to download our Member Access Portal Mobile App. Another class described the different wellness programs available to members.

Members can earn rewards, ranging from \$10 to \$50, by doing things such as getting vaccines, taking a health assessment test or quitting smoking. Health and wellness programs dealing with diabetes, weight loss, heart conditions and caregiving are available to members, free of charge. Classes introduced us to our partners in the plan. These partners include Cigna (Medical Services), CVS (Prescription Drugs), Optum (Behavioral Health) and Amwell (Telehealth Services). Classes also showed the new and expanded features our plan offers in 2024. These include, Behavioral Health Coaching Program, Telehealth-Dermatology, Expanded Hearing Aids, Expanded Foot Orthotics, A1C Testing, Skin Cancer Screening, Infertility, Gender Affirmation, Broad Vaccine Network and SilverScript Prescription Drug (PDP) with \$600 Medicare B Reimbursement. More details and descriptions of these features can be found at nalchbp.org. Classes were also given on subjects such as OWCP, the MBA (Mutual Benefit Association) and Individual Disability Income (an AFLACtype benefit). As you can see, we were given a great deal of valuable information at this seminar. The seminar also briefly touched on the upcoming 2025 Medicare Integration.
